Accurate and timely remittance of contributions matters. MEPP must receive contributions within 15 days from the end of the month. The Municipal Employees' Pension Commission charges interest on late remittances.

## Employer Remittance System

In the last few months we have seen some interruptions of service through the Employer Remittance System (ERS) due to upgrades. Thank you for your patience and understanding during that time.

Remember that if you have a new administrator who needs access to the ERS, fill out a [User Authorization form](#) to get that person their own user name and password. Don't provide your own user name and password to other people – it weakens the security of the system.
