This declaration is to be completed after the death of a member of the Public Employees Pension Plan, where a claim is being made by a common-law spouse and there is no common-law declaration on file.

This form must be witnessed by a Notary Public or Commissioner of Oaths in and for Saskatchewan. If you reside outside Saskatchewan or Canada, please contact PEPP to determine a suitable witness.
